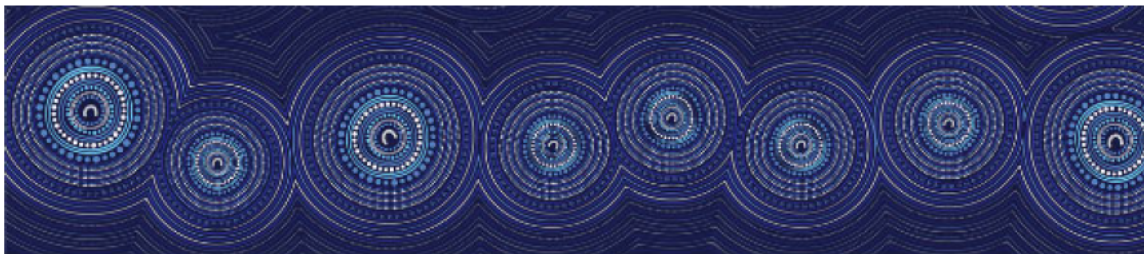

Can we please check with Shane's memory on what he said in this regard.

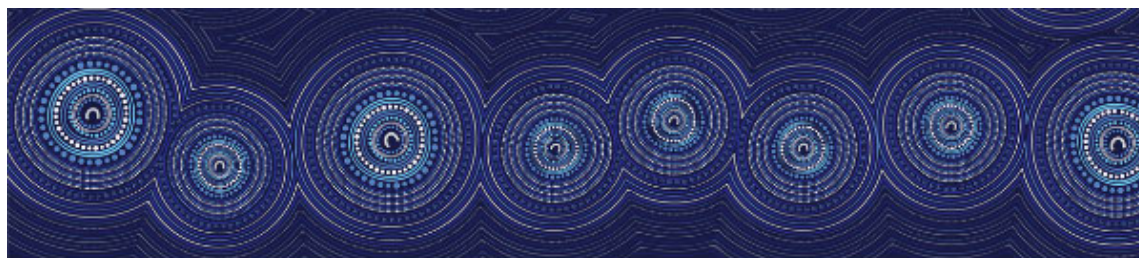
