- 3. I refer to paragraph 84.2 of my 11 April statement and attach to this statement updates I received in relation to the trial in the matter of *R v Lehrmann* in the Signal encrypted AFP/ACT Policing group chat titled 'ACTP Exec' (ACTP Exec Signal messages).
- 4. I do recall taking further action in response to some of the updates I received in the ACTP Exec Signal messages. Particularly, I briefed the AFP Commissioner on politically sensitive issues as they arose during the trial including the fact that Senator Reynolds' evidence had concluded. I refer to paragraph 83.7 of my 11 April statement.
- 5. Having read the ACTP Exec Signal messages, I wish to make the following correction to my 11 April Statement:
 - 5.1. paragraph 91.5 should read 'I attended a teleconference with staff from the Commonwealth Attorney-General's office...', rather than 'I attended a teleconference with staff from the ACT Attorney-General's office...'.
