

As you are aware on 19 April 2021 I formally interviewed Mr Bruce Lehrmann at the Australian Federal Police (AFP) Sydney Office regarding an allegation of sexual assault without consent which is alleged to have occurred at Australian Parliament House on 23 March 2019. In addition Mr Lehmann's mobile telephone was seized under warrant for digital forensic analysis.

A forensic analysis of Mr Lehrmann's mobile phone has been undertaken and potential relevant emails identified, the content of the emails however is stored in the cloud account of Mr Lehrmann. Of particular interest to investigators is an email sent from Mr Lehrmann to Ms Higgins on 24 March 2019.

Investigators are seeking consent from Mr Lehrmann to access the content of the emails stored in Mr Lehrmann's cloud account. Please advise whether your client consents to this access and is willing to provide investigators with the necessary passwords to obtain the relevant emails as specified.
