  - Subject to further order of the Chairperson, the matters contained in the documents lodged with the Board of Inquiry in response to the subpoenas directed to The Proper Officer, ACT Policing Headquarters dated 6 February 2023 and to The Proper Officer, Australian Federal Police dated 20 March 2023 shall not be published or provided to any persons other than:
  - a) for the Australian Federal Police to publish to legal representatives for, the Australian Capital Territory Victims of Crime Commissioner or the Australian Capital Territory Office of the Director of Public Prosecutions / Australian Capital Territory Director of Public Prosecutions, documents to which they may have a claim for Legal Professional Privilege.
