The Director of Public Prosecutions v Bruce Lehrmann

We note the re-trial in the above-mentioned matter is presently listed to commence on 20 February 2023. Mr Lehrmann has been subject to significant prejudice which has impacted upon his right to a fair trial including but not limited to comments which have undermined his entitlement to the presumption of innocence. The conduct which has caused this prejudice includes pre-trial publicity and commentary which have sought to endorse the complainant's credibility and claimed status as a victim.

As you are aware, the Chief Justice on 21 June 2022 vacated the previous trial date of 27 June 2022 arising out of the prejudice occasioned by pre-trial publicity and commentary including the speech by Ms Lisa Wilkinson on live television which sought to endorse the credibility of Ms Higgins and her claimed status as a victim: see *R v Lehrmann (No.3)* [2022] ACTSC 145. As the Chief Justice noted:

"30. The prejudice of such representations so widely reported so close to the date of empanelment of the jury cannot be overstated. The trial of the allegation against the accused has occurred, not in the constitutionally established forum in which it must, as a matter of law, but in the media. The law of contempt, which has as its object the protection of the integrity of the court but which, incidentally, operates to protect freedom of speech and freedom of the press, has proved ineffective in this case. The public at large has been given to believe that guilt is established. The importance of the rule of law has been set at nil.

31. The Crown submitted that the vaccine for the vice of pre-judgment is to empower the jury by giving appropriate directions reminding them that they are uniquely placed to determine the case and directing them to disregard the views of others, who will not have heard all of the evidence.

32. No doubt that can be done in many cases. The present case is different because the author of the impugned remarks will be a key witness in the trial. The central issue in the trial, it is now clear, will be the credibility of the complainant and whether her allegation of sexual assault can be believed. It is not uncommon in such matters for the defence to explore

in cross-examination the way in which a complaint unfolded as the central basis for making submissions to the jury as to whether the complaint should be believed.

33. The irony in all of this is that the important debate as to whether there are shortcomings in the way in which the courts are able to deliver justice in sexual assault cases, to complainants and accused persons alike, has evolved into a form of discussion which, at this moment in time, is the single biggest impediment to achieving just that."

The vacation of the trial date of 27 June 2022 was ordered taking into account a number of factors including, but not limited to, the valuable resources of the Court being wasted, the corrosive effect of delay on evidence, the immobilising effect on an accused of a prosecution pending against him and significant costs thrown away.

As you're aware, at the conclusion of the final day of trial after the jury were discharged, the Chief Justice warned that any publication that prejudices the accused's right to a fair trial may amount to contempt of court.

Statement by the complainant on 27 October 2022

Shortly after the jury were discharged on 27 October 2022, the complainant fronted the Court steps and read aloud a prepared statement to a number of awaiting media. The complainant was accompanied at that time by a number of persons including Ms Heidi Yates, the ACT Victims of Crime Commissioner. It is not known whether Ms Yates was aware of the contents of the statement by the complainant, but her presence alongside the complainant while such a statement was being made, is troubling for reasons which are explained below.

A copy of the transcript of the complainant's statement is *enclosed*.

That statement was widely reported by numerous media outlets. Excerpts of the statement as well as copies of the video of the complainant giving this statement remain online. The statement by the complainant has prejudiced my client's right to a fair trial.

The statement included, but was not limited to, the following:

1. an attack on the criminal justice system by asserting that it has long failed to deliver outcomes to victims of sexual assault;
2. an assertion that because in the ACT during 2020, only 16% of sexual offences reported to police resulted in a charge, and only half of that number again resulted in a conviction, that this was to "our national shame";
3. an expression of thanks to "the people of Australia" who have rallied behind her and those "who chose to attend the March 4 Justice";
4. an assertion that our client was not required to produce his telephone, his passwords, messages, photos or his data. This assertion was false; and
5. assertions which impugned our client's right to silence.

Part of the many aspects of the complainant's statement which are problematic, is what appears to have been a calculated attack on the ACT criminal justice system on the basis that there were not enough convictions of persons charged with sexual assault offences. The statement also sought to link back to previous themes in relation to commentary about this matter including the March 4 Justice rallies which were held on 15 March 2021 in a number of cities across Australia including Canberra. The rallies in part included a public speech by the complainant amongst others, which referred to allegations that the complainant had been sexually assaulted at Parliament House. The complainant's speech on 15 March 2021 outside of Parliament House in Canberra and the ensuing commentary had already caused prejudice to our client and his right to a fair trial. The complainant's more recent statements on 27 October 2022 has irredeemably exacerbated that prejudice.

Firstly, and importantly, the public speech by the complainant on 27 October 2022, whilst accompanied by Ms Heidi Yates, the ACT Victims of Crime Commissioner, could not have been a more calculated attack on the ACT criminal justice system including juries who have the solemn responsibility of determining these matters. Such comments would have the clear tendency to place pressure on any jury which is empanelled to convict our client, lest they are also accused of being part of a criminal justice system that does not deliver outcomes for sexual assault victims. This was exacerbated by the presence of the ACT Victims of Crime Commissioner whilst the statement was being read by the complainant. The presence of the Commissioner could be interpreted to have given the approval of her office to the comments of the complainant.

Secondly, the complainant has insinuated that the people of Australia, including those who attended the March 4 Justice, have rallied behind her as an alleged victim of a sexual assault. This necessarily implied that the people of Australia supported her assertion that she was the victim of a sexual assault by our client. This would have the tendency of placing pressure on a jury which is empanelled to not make a decision which is said to be at odds with members of the community that are said to support the complainant.

Thirdly, we also note that the complainant made a direct reference to Canberra's healthcare workers and system and their responsibility for her 'literally being [here] today'. This is concerning in light of the previous warning made by the Chief Justice during the trial concerning comments not being made which may allude to the complainant's unavailability during the trial.

Social media posts by the complainant

Apart from the statement of the complainant on 27 October 2022, we also note that during the course of the trial, the complainant made a number of posts to social media, including but not limited to, reference to the transcript of a covertly recorded conversation with a crown witness [REDACTED]. We are not aware of any action taken by your office in relation to such media posts by the complainant concerning evidence in the trial whilst the trial was on foot.

In light of the background to this troubling matter and given the fact that the complainant is the key witness in the case that you are intending to prosecute, we write to ask what, if any, action your office is taking in relation to this statement following the jury being discharged.

Without limiting the matters, are you intending to:

1. make any application against the complainant to restrain her from making any further such comments prior to any trial of our client concluding? If so, what application and when will it be made?
2. take any other steps to ensure that the complainant does not repeat her conduct?
3. make any application that the complainant and/or those associated with drafting the public statement, be charged with contempt?
4. take any steps to have removed from the internet, or any other social media forums, any publication of the following:
 - a) any copy of the complainant's full statement or a portion thereof including but not limited to;

The most relevant decision is *R v Charles* [2016] ACTSC 177. The issue in that decision was whether s 9D applies in relation to an application to revoke bail. Refshauge J held that it did not, because:

“The appearance in a court of a person who has been granted bail does not seem to me to revoke the grant of bail. Thus, a person who appears in court ... does not ... have again to apply for bail because he or she is somehow in the custody of the court and which has thereby revoked his or her bail”

Refshauge expressed the view in obiter at [63] that *“bail cannot be required of a person who has appeared in court in response to service on the person of a summons ...”*

The Court of Appeal agreed with Refshauge J’s construction of the Act (but doesn’t address the obiter point): *R v Charles* [2017] ACTCA 35.

So I suppose the answer would be:

- Lehrmann does not have to “apply” for bail
- The presumptions have no application
- There is a real question as to whether there is any power for the Court to remand Lehrmann in custody prior to sentence because he was never arrested/in custody so cannot be said to be in the custody of the court

I will keep thinking about it but that’s all I’ve got for now.
