Notes

Informal service

1. Even if this subpoena has not been served personally on you, you must, nevertheless, comply with its requirements, if you have actual knowledge of the subpoena and its requirements.

Where the addressee is a corporation or agency

2. If this subpoena is addressed to a corporation or agency, the corporation or agency must comply with the subpoena by its appropriate person or proper officer.

Attendance to give evidence

3. Queries regarding your attendance to give evidence should be directed in the first instance to <u>BOI.Notices@inquiry.act.gov.au</u>.

Contempt of Board of Inquiry

- 4. A person commits an offence if the person does something in the face, or within the hearing, of a board that would be contempt of court if the board were a court of record (see *Inquiries Act 1991*, section 36 (**Contempt of Board**)).
- 5. Failure to comply with a subpoena without lawful excuse is a Contempt of Board and may be dealt with accordingly.
- 6. Failure to comply with a subpoena may also be a criminal offence (see *Criminal Code*, section 719 (Failing to attend) and section 720 (Failing to produce document or other thing).

Protections

- 7. Where a person is required to produce a document (or other thing) or answer a question to the Board of Inquiry, that person is not able to rely on the common law privileges against self-incrimination and exposure to the imposition of a civil penalty to refuse to produce the document or other thing or answer the question (see *Inquiries Act 1991*, section 19 (Privileges against self-incrimination and exposure to civil penalty)).
- 8. However, anything obtained because of the producing of the document or other thing, or the answering of the question, is not admissible in evidence against that person in a civil or criminal proceeding, except for an offence relating to the falsity or misleading nature of the document or other thing or answer, and for an offence against chapter 7 of the *Criminal Code* (see *Inquiries Act 1991*, section 19 (Privileges against self-incrimination and exposure to civil penalty)).

 - (a) Whether any police officers failed to act in accordance with their duties or acted in breach of their duties:
 - (i) in their conduct of the investigation of the allegations of Ms Brittany Higgins concerning Mr Bruce Lehrmann;
 - (ii) in their dealings with the Director of Public Prosecutions in relation to his duty to decide whether to commence, to continue and to discontinue criminal proceedings against Mr Lehrmann in relation to those allegations;
 - (iii) in their dealings with the legal representatives for Mr Lehrmann before, during or after the trial in the matter of *R v Lehrmann*;
 - (iv) in their provision of information to any persons in relation to the matter of R v Lehrmann.
 - (b) If any police officers so acted, their reasons and motives for their actions.
 - (c) Whether the Director of Public Prosecutions failed to act in accordance with his duties or acted in breach of his duties in making his decisions to commence, to continue and to discontinue criminal proceedings against Mr Lehrmann.
 - (d) If the Director of Public Prosecutions so acted, his reasons and motives for his actions.
 - (e) The circumstances around, and decisions which led to the public release of the ACT Director of Public Prosecutions' letter to the Chief Police Officer of ACT Policing dated 1 November 2022.
 - (f) Whether the Victims of Crime Commissioner acted in accordance with the relevant statutory framework in terms of support provided to the complainant in the matter of R v Lehrmann.
 - (g) Any matter reasonably incidental to any of the above matters.
- 2. The Board will report to the Chief Minister by 30 June 2023.



Our client: Fiona Brown

We act for Fiona Brown.

We refer to the decision by the Chief Justice on 29 June to vacate the Lehmann trial (at which our client is to be called as a Crown witness) following the broadcast of the *TV Week Logies Awards* on 19 June 2022: *R v Lehrmann (No 3)* [2022] ATSC 145.

We note the observations of the Chief Justice that "The central issue in the trial, it is now clear, will be the credibility of the complainant and whether her allegation of sexual assault can be believed".

We note that on 18 May 2022, our client and counsel attended a conference with you and those appearing with you and instructing you at the trial.

During that conference, we are instructed that our client raised her ongoing distress with respect to false and defamatory publications concerning her, in particular the Ten Network's *The Project* interview of Ms Higgins. She also raised her concerns about the upcoming broadcast of the *Logie Awards* in which the interview was nominated for an award.

As you know, an extract of that interview (**Interview Extract**) was replayed during the live broadcast of the *Logies Awards*, and the program remains accessible online. We note that our client is explicitly identified by Ms Wilkinson in the Interview Extract. Our client rejects the words attributed to her by Ms Higgins in the Interview Extract.

We bring to your attention that there are material differences between the Interview Extract broadcast by the Nine Network and the original Interview as broadcast by the Ten Network in February 2021 (transcript enclosed).

We set out the two extracts as follows:

Nine Network broadcast of Interview Extract:

WILKINSON: And I believe that Fiona Brown from the Prime Minister's office gave you two choices

HIGGINS: I asked so what is the process of coming back, she said "well you wouldn't" and that was the really clarifying moment for me where I fully sort of internalised that this is a political issue, my job is on the line for this and I really don't have a choice.

Original Ten Network broadcast of Interview:

WILKINSON: And I believe that Fiona Brown from the Prime Minister's Office gave you two choices on how to proceed?

HIGGINS: Essentially I could go home. They'd pay me, I would technically be employed, in six weeks' time our contracts are going to expire anyway and I could sort of take leave and just sort of process what had happened to me and I could just go home.

WILKINSON: To try and heal?

HIGGINS: Yeah. And I asked, so what's the process of coming back and she ... said, well, you wouldn't and that was the really clarifying moment for me where I fully sort of internalised that this is a political issue, my job is on the line for this and I really don't have a choice.

WILKINSON: So what did you choose?

HIGGINS: This was my dream job. I had worked my entire life to get here. I wanted this future. I wanted to be a part of it, for my entire working life. So yeah I went to WA.

It is thus clear that steps were taken, either by the Nine Network, or the Ten Network, to edit the original interview.

It is not clear whether the editing was done, or authorised, with the intention of, or was reckless to the risk of, intimidating our client in relation to the evidence she will give as a witness in the trial.

In any event, it gives an impression to prospective jurors and the community at large of our client as having acted inappropriately, unprofessionally and dishonestly in relation to Ms Higgins and her allegations. That is, that she is an untrustworthy and dishonest person, who sought to silence Ms Higgins for political reasons.

This impression was only reinforced, if not exacerbated, by the subsequent broadcast of the radio program "Jonesy and Amanda". We refer to paragraph 23 of the Chief Justice's judgment:

The transcript attributes to "Jonesy" his assent to that recollection. He later refers to the fact that, "...the whole story was dreadful. Absolutely dreadful", adding, "[j]ust the very fact that she had to have a meeting in the very room that she was raped with her superiors and then her career was virtually finished." And so on.

By reason of the prior publication of the Interview Extract and Ms Wilkinson's award acceptance speech, the reference in the radio program to "her superiors" was clearly to be taken as a reference to our client. Our client rejects utterly the implication that she required Ms Higgins to "have a meeting in the very room that she was raped", because apart from the statement assuming that a rape had in fact occurred, Ms Higgins had not made any such allegation to our client (nor did she subsequently).

Needless to say, these recent events have caused further harm and great distress to our client who is very concerned that precisely the evidence that she is expected to give has been and is being canvassed in public by another witness, with the full weight of national television and radio networks behind her, in such a way as to sow doubt in the minds of potential jurors as to the veracity of our client's account of events and her credibility, whilst bolstering that of Ms Higgins and Ms Wilkinson.

We are concerned not only about the effect upon potential jurors (being the reason Her Honour has vacated the trial and so in effect grant a temporary stay) but with the intentional or unintentional intimidation of our client as a witness in the proceedings, by holding her up to public condemnation.

In our view, the actions of Ms Wilkinson and the respective networks are capable of amounting to a very serious contempt.

Accordingly, we seek to arrange a further conference with you and our client to discuss these matters and arrangements for our client's evidence at your earliest convenience.







INTERSTATE WITNESS FACT SHEET

If you are travelling from interstate to attend Court and live more than 60km from the ACT, the Office of the DPP will pay for, or reimburse you for, your reasonable costs directly related to your attendance at Court to give evidence, in excess of the conduct money, if receipts, displaying GST where relevant, are attached to your *Witness Expenses Claim Form*.

All forms and further information are available from the ACT DPP website – www.dpp.act.gov.au.

You should have received conduct money with your subpoena. This amount is automatically deducted from your claim (excluding wages).

Claims take approximately 28 working days from the time we receive a valid claim from you. The money will be deposited into the bank account you nominate on the *Witness Expenses Claim Form.* Money claimed by your employer will be deposited into the employer's bank account.

Lost Wages / Income

If you did not receive your wages/salary which you would otherwise have been entitled to as a result of attending court to give evidence, the DPP will reimburse you for reasonable lost wages or salary. You must complete the **ACT DPP Loss of Income Claim Form – Employee** and attach a copy of your payslip.

If you are self-employed, the DPP will reimburse you for reasonable lost income as a result of attending Court to give evidence. You must complete the **ACT DPP Loss of Income Claim Form – Self Employed** and attach proof of income. If you are subpoenaed to give expert evidence, you will be paid according to the recommended fees for your particular professional group, where relevant. Please contact ACT DPP Corporate for further clarification.

If your employer paid you wages or salary for the time you attended Court to give evidence, the DPP will reimburse your employer directly. Your employer must complete the **ACT DPP Loss of Income Claim Form – Employer** and attach a copy of your payslip

Travel from Interstate

The DPP will provide one economy class return ticket to and from your nearest airport. The DPP will make the booking and pay for your ticket in advance. We will notify you of your travel details. If air travel is impractical, we may, if appropriate, arrange bus travel. If it is impractical to travel by other means, we will reimburse you for the kilometres travelled from your usual place of residence to Court and back (based on the Australian Taxation Office business kilometre rate). To claim these expenses you must tell us the kilometres travelled.

Accommodation

If you are travelling from interstate, the DPP will arrange accommodation (minimum 3 stars) for you in Canberra. Our Office will pay the hotel directly. (Accommodation will not be arranged for those travelling from NSW areas reasonably close to the ACT). We will let you know the details of the hotel we arrange.

We will not pay for any additional expenses incurred by you during your stay (eg ordering food from room service, consuming items from the mini-bar, telephone calls, pay per view movies etc).

<u>Meals</u>

Witnesses from interstate who have to stay overnight are entitled to be reimbursed, on submission of valid receipts, displaying GST where relevant, for the cost of meals up to the maximum amount. For overnight meal rates, see the ACT DPP website, under 'Witness and Victim Services – Claiming Expenses'. Meal rates are updated annually.

If breakfast is supplied as part of the room rate, you cannot claim reimbursement for breakfast. The DPP will not reimburse you for the purchase of alcohol. Receipts must be attached to your *Witness Expenses Claim Form*.

Local Transport

If you are travelling by air from interstate, the conduct money is intended to cover the cost of transport from your home to the airport and return. The conduct money which accompanies your subpoena is intended to cover local transport costs such as taxis, buses or small distances travelled within the ACT by private vehicle. We will reimburse you for any reasonable travel costs you incur in excess of the conduct money if receipts are attached to your *Witness Expenses Claim Form*.

Parking

The conduct money which accompanies your subpoena is intended to cover any parking expenses. We will reimburse you for any reasonable parking expenses incurred in excess of the conduct money if receipts are attached to your *Witness Expenses Claim Form.*

Childcare

Please note our office is not able to assist with arranging care while you are giving evidence. Parents or guardians are responsible for ensuring arrangements are in place and this WILL NOT be arranged by the ACT DPP. Reasonable expenses will be considered on a case-by-case basis with receipts attached.

I have consulted with our Corporate team and confirm that we can book the following:

Unfortunately my lawyer is unavailable today but advised me to make urgent contact with the Crown Prosecutor.

I am disturbed by the evidence presented by Ms Higgins this morning after reading her testimony online.

Statements made by Ms Higgins are false and and misleading regarding what I said to her. She categorically has stated that 100% I said the following:

Ms Higgins said Linda Reynolds' chief of staff Fiona Brown offered to pay her six weeks' wages to go to the Gold Coast during the election campaign but that if she went, there would be no prospect of her returning to work after the election.

They said they would pay me out for the entirety of the election to go to the Gold Coast but there would be no prospect of me coming back," she said.

"That was 100 per cent said.

"That was a conversation Fiona Brown and I had and that was the tipping point of me going to Perth."

Neither Minister Reynolds or I had the authority to pay any staff member out. And I did not at any time state or suggest this.

You have messages I provided in my evidence to the police which clearly show that flowers and cake were for a staff farewell not by way of any gift to me or the office and she was reimbursed in cash.

I am deeply troubled by this serious misrepresentation in proceedings and I seek to have them corrected or put to me in court.
