Dear all,

For your awareness, the Director of Public Prosecutions has responded to the letter and preliminary brief in relation to Operation Covina submitted by D/Supt Moller on the 18th of June 2021.

Until the end of July, you are each assigned to Op Covina, reporting to me. Working hours are 8am to 4pm Monday to Friday unless operationally required to be varied.

The aim of this activity is to address concerns raised by the Director as per his response, and to provide him with as complete a picture as possible.

The Director's response, together with some notes in relation to further avenues of inquiry compiled, I believe by Trent, are attached.

Also attached is a spreadsheet with an indication of the avenues of inquiry as compiled by me, and an allocation of tasks to members. I have assigned those tasks based on prior involvement with witnesses, etc.

You might note there are some "double ups" in terms of members with particular taskings for the sake of redundancy, and sharing of workload - naturally there is no need for two members to be involved in obtaining a statement from an individual, so I would ask that you determine who of the two members is either available or best suited to undertake that tasking. These taskings are not set in stone - if someone has more capacity than someone else to take on a particular task, please let me know and I'll update the spreadsheet accordingly.

The timeframe for the completion of these inquiries and for statements to be obtained is 31 July 2021.

I note that members availability is somewhat patchy this week due to ill health, looking after children, and training courses.

I would ask that we are all on deck (other than Trent who isn't back until Wednesday 14 July) on Monday 12 July 2021 at 9am for a briefing in D/Inspector Boorman's office. The next briefing will be 11.30am on Wednesday 14 July 2021 when we should be all on deck.

I'll be away all day tomorrow (Thursday 8 July) and next Wednesday (14 July) until about 11am. I'll be in on Friday (9 July) to have a chat with Sarah and Emma (if you're available by then).
