Hi Helen

I've just had a call from Steven Whybrow to say that:

- * They're unlikely to challenge the claims we have made, given what we produced, although Steven couldn't finally confirm that yet.
- * A short-return subpoena was issued this morning for D/Supt Scott Moller to attend to give evidence on 29 September 2022. It will probably be served soon, if it has not been already.
- * The subpoena is just for the avoidance of doubt - Steven said that Scott could assume he won't be required to attend to give evidence unless he hears otherwise.

I'll be in a partly closed hearing this afternoon but it sounds like there shouldn't be any major issues today.
